



FUNDRAISING FAQ'S

WHAT DOES A FUNDRAISER EVENT ENTAIL?

Fundraisers are in-store scheduled events in which The Melt will donate 25% of all sales (pre-tax) generated by your organization when a fundraiser flyer is presented at the time of purchase.

WHO CAN HAVE A FUNDRAISER?

Fundraisers are open to any school or youth sports league with a Tax I.D. number and recognized by the government as a non-profit organization (501 c3) such as:

- Public Schools
- Parent Teacher Organizations
- Sports Teams
- Campus Clubs
- School Bands
- School Camps
- Student Councils
- Booster Clubs
- Sororities / Fraternities

The Melt will not support organizations that discriminate against a person or group on the basis of age, political affiliation, race, national origin, ethnicity, gender, disability, sexual orientation or religious belief.

HOW DO I KNOW IF THE GOVERNMENT RECOGNIZES MY ORGANIZATION AS A NON-PROFIT?

To find out if your organization is recognized by the government as a non-profit or has 501 (c)(3) status, please contact your organization. The Melt cannot provide you with this information.

WHEN CAN I SCHEDULE A FUNDRAISER NIGHT?

Sunday-Thursday, 3pm-close. Certain blackout dates and limitations will apply due to store availability.

HOW FAR IN ADVANCE SHOULD I SUBMIT MY REQUEST?

We ask that requests to be submitted at least 30 days before the desired fundraiser date.

HOW CAN I REQUEST A FUNDRAISER?

Online request forms can be submitted [here](#). Completing the online request form does not confirm an event. You will receive an email confirmation and a customized event flyer when approved. Approval of all requests is solely at the discretion of The Melt.



FUNDRAISING FAQ'S (CON'T)

WHAT HAPPENS ONCE I SUBMIT A FUNDRAISER REQUEST?

Once a request is submitted, it is reviewed by The Melt for approval. You will be contacted with the necessary forms if your event is approved.

HOW SHOULD I PROMOTE MY EVENT?

HOW LONG WILL IT TAKE FOR MY ORGANIZATION TO RECEIVE THEIR CHECK?

Checks will be mailed 4-6 weeks from the date of the fundraiser.

ARE THERE ANY ADDITIONAL REQUIREMENTS TO HOST A FUNDRAISER?

To ensure a successful fundraiser, we ask that the event organizer(s) confirm the expected amount of attendees by sending an email to fundraising@themelt.com 24 hours prior to the event.

WILL TO-GO ORDERS COUNT TOWARDS A FUNDRAISER?

Yes, as long as each guest presents a flyer at the time of purchase.

WILL GIFT CARD PURCHASES COUNT TOWARD FUNDRAISERS?

Gift card purchases will not count toward fundraisers.
